The objects of the Club are the encouragement of yacht sailing, cruising and racing, and the maintenance of a Clubhouse for the use of the Members.

Persons between 18 and 40 years of age may be elected Associate Members, with full use of the Club's facilities except the dinghy hard, but with no other rights, for a maximum period of two years. On completion of two years of Associate Membership an Associate Member shall become ineligible for any further term but may apply at any time for Full Membership under Rule 5(a). Associate Members shall not be entitled to the privileges of voting, passing resolutions, or taking part in the business of the Club. Nor shall they be entitled to fly the Club Burgee nor wear the Ensign, nor to wear Club insignia.

### SUBSCRIPTION:

If elected a candidate shall pay his Subscription within fourteen days of receiving notice of election.

Member's future Subscription shall be paid by Banker's Variable Direct Debit Mandate to the Club Bankers for the account of the Club.
